FEPEDA STATEMENT – COVID-19

In the context of this pandemic situation, the European Federation of Parents of Hearing Impaired Children (FEPEDA) is aware that deaf and hard-of-hearing people are facing multiple barriers and calls European, national, regional and local authorities to assure their rights, recognised by UN CRPD:

Right to information: Persons with a hearing disability has the right to access to information simultaneously to the rest of the population. All the information provided online or recorded by audiovisual means (tv broadcasting or through internet) must include subtitling and sign language interpretation.

Right to health:

Access to emergency numbers: Different emergency numbers have been established in this context. It is essential to assure its accessibility through writing and videoconference.

Functioning of hearing aids: It is essential to assure the supply of batteries and spare parts of hearing aids and earing implants, as well repairs services.

Right to education: European children and young people are now studying at home, online education must be accessible for them: speech to text in teacher's instruction and in any other audio material, subtitled audiovisual materials, written indications and guidelines for home work must be used, as well as sign language interpreters for those students who use this language.

Right to (re)habilitation: The public authorities must provide online resources to ensure that early attention and speech therapy services continue for deaf and hard-of-hearing children and teenagers, in order not to affect their progress or make the consequences of their hearing impairment worse, due to lack of specialized attention.

Right to leisure and culture: It is essential that TV programmes, including those for children and young people, are accessible, through subtitling and sign language interpretation.

Right to social protection: A disability in the family is an economical burden. Families with a deaf or hard-of-hearing member must be considered as vulnerable group in the future social protection measures

Right to be consulted: All the adopted measures must be consulted with the organisations representing deaf and hard-of-hearing persons and their families and their sustainability must be assured.

We, deaf and hard-of-hearing children and young people and their parents, will stay at home, but please do not leave anyone behind!



World Hearing Day 2020 Hearing for life: Don't let hearing loss limit you

(Helsinki, 3.3.2020) The European Federation of Parents of Hearing Impaired Children (FEPEDA), the largest platform representing families of deaf people in the European Union, is endorsing the World Hearing Day campaign, launched by the World Health Organization (WHO).

Under the motto chosen by the WHO, *Hearing for Life: Don't let hearing loss limit you*, FEPEDA wants to remind that thousands of children are born with a hearing loss every year, in the European Union.

The current legislative framework in the European Union and all its Member States enshrines the fundamental rights of deaf and hard-of-hearing people and establishes the responsibility of the public authorities to guarantee their exercise. The EU and its 27 member states have signed the United Nations Convention on the Rights of Persons with Disabilities.



However, early detection of neonatal deafness is far from being a reality in all EU countries. Early intervention is not always adequate, timely and sufficient. Hearing aids (traditional hearing aids and/or hearing implants) are a major financial burden for many European families. Support resources of all kinds are lacking in many schools in Europe. There are not enough aids or support for families. And leisure, culture, recreational activities are often inaccessible to children and young people with deafness.

If we want an inclusive Europe, where no one is left behind, it is essential that EU institutions and national authorities invest in deaf and hard-of-hearing children and young people, ensuring the resources and support they and their families need at the right time, so that hearing loss don't limit them.

News from Bulgaria

At the beginning of 2020, the Bulgarian Association of Parents of Hearing-Impaired Children launched an online consultation service for the hearing impaired and their families. The platform was developed as part of project BGo5M9OP001-2.011-0006 "Equal Opportunities for Hearing-impaired Children and their Families" funded by Operational Program Human Resources Development 2014-2020, Priority Axis 2, „Reducing poverty and promoting social inclusion”, co-financed by the European Union through the European Social Fund.

The main idea was to give an opportunity to people in remote settlements to have access to different types of special services as psychologist, sign language interpreter, supported education and employment, speech therapists

The lockdown of the world caused by the Covid pandemic is hard for everyone, but especially for disadvantaged people. But we faced it continuing to offer all services for people with hearing impairments and their families by the platform.

From the very first day of the state of emergency, all broadcasts news on the national televisions, as well as the daily government briefing, are supported by sign language interpreters in the frontline. This is a big step forward in ensuring equal access to information to the deaf people.

This essential necessity for deaf community is starting to be commented actively on the medias and to focus the attention of whole the society. We are deeply convicted that these times are also times for positive changes. And we will continue to work for it even hard.

Information Centre of Parents and Friends of the Hard-of-Hearing celebrates 30th anniversary

Centre for Children with Hearing Impairment Tamtam is an affiliated organization of our Information Centre and the other successional organization of The Federation of Parents and Friends of the Hearing-Impaired which was founded by parents in 1990. That means that both organizations are celebrating their 30th anniversary this year – same as FEPEDA itself.

In these 30 years we were able to help over 20 000 families with children with hearing impairment in Czech Republic. Everyone who has ever come in contact with any kind of hearing disability knows that since the day one it is a long and stressful journey, especially, with small children.

We are here not only to help them with all the medical matters, but also as a psychological support and just as a friend they can turn to. For this year we prepared all kinds of celebrations. The aim was to get together as many of our current and former clients and to show them how fulfilled can be a life of a child with hearing impairment. We still hope that some of these events will be realized.

One of these events is in October and it is concerned with early intervention – it is a conference called ECI Conference EURLYAID 2020. We do not organize it but we partake and we hope that it will bring some important new info and also that it will draw attention to some current problems.

Our ICPFHH and Tamtam really needed to change the range of work during these challenging times regarding the COVID-19 situation. Counsellors are working from home therefore they use online platforms to connect with the families, they put online a plenty of exercises and other stuff to keep the kids on track and we hope that we will be able to continue our work within previous standards.

Information centre currently participates on all the activities of Tamtam, we are working together and as a team we are trying to handle this situation. One of our greatest projects is creating of the videos in sign language with subtitles. These can be found on one of our websites:

News from France

Situation of employment of deaf and hearing-impaired people in France

This article provides the situation of employment of deaf and hearing-impaired people in France based on figures issued from a survey from INPES (National Institute for Health Prevention and Education) in 2011/2012.

Between 5 and 6 million people are deaf or hearing impaired in France. 1,4 million are of working age:

- One third are unemployed (against 26% for whole population), what means about 500 000 people:
 - o 15% give up working for health reasons (3% for whole population)
 - o 34 % of profound deaf people give up working (1 out of 3)
 - o 15% of hearing-impaired people with average deafness give up working (3 out of 10)
 - o 12% of hearing-impaired people with light deafness give up working (2 out of 10)
- We need to notice that deafness level has an impact of employment rate for deaf or hearing-impaired people. Deeper is deafness, lower is employment rate (34% for profound deaf people and 71% for hearing impaired people)

Opinion on deaf or hearing-impaired people employment

To engage a deaf or hearing-impaired person is rather easy from the point of view of:

- General Public: 58%
- Employees: 48%

- Employers: 42%

Working with a deaf or hearing-impaired person is rather easy for 48% of responding people. This rate can be different according employee situation in work context:

- If several colleagues with disability: 62%
- If only one colleague with disability: 50 %
- If no colleague with disability: 39 %

Support to deaf and hearing-impaired workers

- Sign language interpreters: 62.1 %
- Remote interpretation or phone amplifier: 20%
- Magnetic loop or microphone device: 15%
- Communication interface: 12%

Feeling of deaf and hearing-impaired workers

- 25 % have the feeling to be threaten in their job: they are afraid to lose their job
- 41,8% say that they are disturbed by the noise.

if they have hearing aids and in case of vibrations

- 60% say that their job is nervously tiring, especially for executives
- 50% say that they are in psychological

and 70% among them say that it is due to their job

- 22,1% thought about committing suicide and 45,1% among them say that it is due to their job
- More than 1 worker on 10 say that they attempt suicide and more than 1 out of 5 for professional reasons

Items to work for a better professional inclusion and a better work quality of life

- Deafness would be a reason of non-recruitment and non-access to some jobs
- Lack of information and awareness of people involved in employment on the needs of deaf and hearing-impaired people and ignorance of needed tools to communicate with them would be obstacles to recruitment and professional evolution
- Deafness would hide some skills of deaf workers and their capacities to have jobs with responsibilities
- Deafness would be often associated to less capability
- 74% of deaf workers think they have less opportunities to be promoted than their hearing colleagues
- There is a big strong feeling that efforts are always in the same way, leading to mental and physical tiredness
- Social isolation would be often suffered inside the company

Suggestions to improve insertion and sustainability in employment of deaf and hearing-impaired people

- To reinforce access and accessibility to trainings (initial and continuous) and learning
- To facilitate human aid intervention to make accessible communication (meetings, interviews,): Sign Language interpreters, cued speech coders,
- Inside the company, to provide to deaf and hearing-impaired workers communication and information technologies according their needs
- To reinforce managers awareness and colleagues on deafness and specific communication problematics
- To prevent social isolation and psychological distress of deaf workers inside the company (psychosocial risks)

FIAPAS PUBLISHES THE RECOMMENDATIONS FOR UPDATING EARLY DETECTION PROGRAMMES OF CHILD DEAFNESS

The Spanish Confederation of Families of Deaf People (FIAPAS), in collaboration with the Commission for the Early Detection of child Deafness (CODEPEH) and with the co-organisation of the Royal Board on Disability, has published a new document as a result of the project 'Updating of early detection programmes for child deafness (Diagnosis, Treatment and Monitoring)', the aim of which is to complete the recommendations regarding neonatal hearing screening programmes.

The new document, entitled 'Updating of Early Detection Programmes for Childhood Deafness: CODEPEH 2019 recommendations (Levels 2, 3 and 4 Diagnosis, Treatment and Follow-up)', which draws on recent scientific evidence, addresses the critical points of update on etiological and audiological diagnosis, as well as issues related to the treatment of congenital deafness, highlighting the importance of binaural hearing and warning that unilateral deafness is not without negative consequences on the child's development, and therefore treatment and follow-up are also required. In this regard, the expansion of indications for cochlear implantation is also addressed.

Programs for early detection of congenital hearing loss have been successfully established mainly in developed countries, after overcoming some conceptual errors against their implantation or some critics of their efficacy. However, some difficulties and weaknesses are still identified in them: the detection of late-onset hearing loss and the percentage of children who did not pass the screening and did not complete the process of diagnosis and treatment, being cases that are lost in the process.

The purpose of this Document is to analyze these problems to determine areas for improvement and to emphasize one of the basic principles for the success of the programs: the continuous training for the interdisciplinary team.

The result of the review process carried out by CODEPEH is drafted as Recommendations for updating the Programs with the evidences of the last decade, the advances in the screening technology, the impact of the present knowledge on congenital infection by cytomegalovirus, the genetic hearing loss researches and control systems of lost to follow-up cases.

The document also focusses on the important role of the families during the whole process, highlighting that Families Associative Movement must be an essential point of support.
